We will be leaving from JMPHS at 3:00pm on Friday, April 26th, and returning early Saturday morning, April 27th. Students must attend school on Friday, April 26th, to attend. All students must ride the charter bus to and from GRAD BASH. No students may drive separately or meet us at the park and all students must ride back with us to JMPHS.

The total cost per senior is \$162.50, which includes tickets and transportation. To reserve your senior's place on the trip, please complete the attached permission slip and submit with the deposit of \$75 no later than Friday, December 7th, 2018. *Please note that this deposit is necessarily nonrefundable*. The remaining balance of \$87.50 will be due no later than Friday, March 23rd, 2019.

If you prefer to pay the amount in full, please do so by December 7th. Please have your senior turn in all items in a sealed envelope with his/her name on it to me, Mr. Bunch, Mr. P. White, or to Denise Mattair in the front office. Checks and money orders must be written to James Madison Preparatory High School. If you are writing a check or submitting a money order, please include your senior's full name in the subject line.
